Affiant declares under penalty of perjury that the following facts are true and that there is probable cause to believe, and Affiant does believe, that the designated articles, property, and persons are now in the described locations, including all rooms, buildings, and structures used in connection with the premises and buildings adjoining them, the vehicles and the persons:

I, the affiant, Deputy Seth Tunstall, have been a sworn Deputy Sheriff since August 11, 1999. I am currently employed by the Orange County Sheriff's Department as a Deputy Sheriff. I have currently been assigned to the Federal Santa Ana Gang Task Force (SAGTF) for approximately the last four years.

Between February 1999 and August 1999, I attended the Orange County Sheriff's Academy where I received nine hundred and sixty (960) hours of law enforcement training. This training included courses in theft, burglary, robbery, assault, homicide, narcotics, weapons violations, sex offenses, identity theft, street gangs and violent crimes. After completing the Academy, I was assigned to the custody division and have worked since then at Theo Lacy Facility, a men's maximum security county jail. While working at the Theo Lacy Facility, I have had contact with thousands of inmates and spoken to them regarding their criminal activities and learned their methods of committing crimes and concealing them from law enforcement. I have spoken to numerous inmates about the commission of vehicle thefts, burglaries, robberies, economic crimes, narcotic violations, homicides, assaults, conspiracy cases, gang affiliation/association, weapon violations and extortion.

During approximately my first one and half years at Theo Lacy Facility, I worked as a housing prowler in the Maximum Security modules and was responsible for maintaining safety and security within the jail. For approximately one year, I was assigned to the classification detail where I was responsible for the classifying and housing of inmates based on numerous factors including charges and criminal sophistication; and the overall supervision of any jail inmate movement within the facility.

In September 2001, I was assigned to the Special Handling/ Gang Detail at Theo Lacy Facility. This detail consists of one Sergeant and four deputies that work from within Theo Lacy Facility. The Special Handling/ Gang Detail is responsible for:

Gathering intelligence on gang shot-callers/ representatives, gang rivalries in and out of custody, narcotic trafficking within the jail system, developing confidential informants, "Green-lights" on specific gangs and gang participants, identifying street/prison gang participants, identifying subjects who are gang dropouts or who are on hit lists, evolving gang trends and politics both on the street and in-custody.

Screening inmate mail for monikers, grafitti or drawings, gang related photos, possible escape plans, validating gang association, plans for assaults on staff/ other inmates, plans for future criminal activity, past criminal activity not previously known.

Interview all high power gang participants as they enter the facility, identify gang rivalries and alliances, determine proper housing for gang drop outs, investigate assaults and determine gang involvement, identify trends within the gang subculture, identify and photograph gang affiliated subjects and their tattoos, monitor and track the movement of high power gang participants both in and out of custody.

Assist outside agencies in identifying subjects, forward gathered information on gangs to the appropriate jurisdiction, provide intelligence at meetings as it applies, assist the California Department of Corrections in validating prison gang members who are in or who have left the Orange County jail system, and assist the Orange County District Attorney's office in ongoing criminal cases.

Monitoring inmate phone calls for monikers, possible escape plans, validating gang association, plans for assaults on staff, other law enforcement agenices and other inmates, plans for future criminal activity, past criminal activity not previously known, and narcotic trafficking within the jail system.

From January 2010 to the present, I have been assigned to the Federal Santa Ana Gang Task Force (SAGTF). The SAGTF consists of the following agencies: Santa Ana Police Department; Orange County Sheriff's Department; Federal Bureau of Investigation; Alcohol, Tobacco and Firearms; United States Attorney's Office; Orange County District Attorney; and the California Department of Corrections Special Services Unit. The SAGTF primarily focuses on the career criminals, which includes active gang members and associates currently involved in serious or violent crimes; organized crime involving the Mexican Mafia; along with narcotic and gun trafficking and distribution.

My informal and infield training includes receiving information/training from numerous Orange County Deputy District Attorneys and Investigators, Riverside Deputy District Attorney's and Investigators, OCSD Gang Investigators, outside agency Gang investigators, California Dept. of Corrections Institutional Gang Investigators from Pelican Bay State Prison, Tehachapi State Prison, Corcoran State Prison, Wasco State Prison, Chino State Prison, Calipatria State Prison, Centinela State Prison, Folsom State Prison, Region 4 Parole SSU-IGI Lt L. Duarte, SSU S. Gutierrez and SSU-IGI Lt R. Marquez, and the Federal Bureau of Investigation. I have drawn from their knowledge and expertise in their respective fields of law enforcement.

During my employment with the Sheriff's Department, I have cultivated, interviewed and supervised numerous confidential informants. I have also interviewed witnesses, suspects, and compiled the necessary information to help obtain arrest/search warrants. Sheriff's Dept., Riverside Sheriff's Dept., San Diego Sheriff's Dept., California Dept. of Corrections, Santa Ana Police Dept., Anaheim Police Dept., Costa Mesa Police Dept., Huntington Beach Police Dept., and the California Gang Investigators Association. I am currently a member of the California Gang Investigators Association (CGIA), the Orange County Gang Investigators Association (OCGIA), California Gang Task Force (CGTF), and the California Narcotic Officer's Association (CNOA) These organizations have annual seminars which include training on gang theories, activities, and trends. The OCGIA and CGTF have monthly meetings in which local gang enforcement police agencies in Orange County gather and share information pertaining to their respective gangs.

During my law enforcement career, I have been involved in the investigation of several hundred gang-related crimes and activities. I have spoken to more than 4000 gang members in both custodial and non-custodial settings. During these contacts I spoke to the gang members about their gang's history, their associates and rivals, their tattoos, clothing, area of activity, and the type of crimes they commit. Through the investigations and contacts I have had, I have learned the values, customs and operations of criminal street gangs, including their attitudes and behavior towards rival gangs, weapons, violence, law enforcement, and their loyalties to and expectations of fellow gang members. I have read numerous books on the subject of gangs, their history, and their culture. These books were authored by not only law enforcement officers, but former gang members and scholars.

As a sworn deputy, I have participated in the service of several search warrants involving gang members. During these search warrants I have had the opportunity to see and seize gang indicia, which included personal writings, photographs depicting gang members, and phone books showing names and phone numbers of fellow gang members and associates.

I have testified as a gang expert in Orange County Superior Court North Justice Center, Orange County Superior Court West Justice Center, Orange County Superior Court Central Justice Center, the Federal Grand Jury in Santa Ana, and the Orange County Superior Court Grand Jury.

Lam personally aware, through prior investigations and discussions with gang members, of a criminal street gang called Varrio Midway City. Lam also aware members and associates of the Varrio Midway City criminal street gang have been engaged in an ongoing pattern of violent criminal behavior to include, assault with a deadly weapon, narcotics for the purpose of sales, terrorist threats, and possession of loaded and concealed firearms in public.

Based on my training and experience with criminal street gangs and their active participants coupled with the following facts in this affidavit:

- I have formed the opinion that active participants of criminal street gangs normally keep mementos of their gang membership and/or affiliation at their residences in the form of scrapbooks, photo albums, personal phone books, personal videos, handwritten signs, wall plaques, computer disks, computer hard drives. In addition, graffiti symbolizing the gang can be found often time inscribed or written on such items such as CD players, tape recorders, sporting equipment, walls, cabinets, furniture, and other personal items. This opinion is based upon my personal experience and observing such items in residences of active participants of criminal street gangs numerous times in the past.
- I have formed the opinion that active participants of criminal street gangs frequently pass firearm (s) from one active participant to another to use in their gang's daily activities. When the firearm(s) are used in a crime, that firearm (s) may be concealed until the danger of detection has passed. The active participant who last had the firearm will either conceal the firearm(s) or he or she will deliver it to another fellow active participant to be concealed until the danger of detection has passed. When the danger of detection has passed that firearm(s) will be delivered back to the gang to be used once again.
- 3 It is my opinion that active participants of criminal street gangs frequently possess or borrow cars owned by family members, friends, girlfriends, or other active participants. They will hide or leave gang paraphernalia or weapons within these vehicles. This opinion is based on my personal observations and conversations with active participants of criminal street gangs numerous times in the past.

I am personally aware, through prior investigations and discussions with gang members, of a criminal street gang in the city of Midway City called "Varrio Midway City". I am also aware members and associates of the "Varrio Midway City" criminal street gang have been engaged in an ongoing pattern of violent criminal behavior to include, assault with a deadly weapon, auto theft, burglary, narcotics for the purpose of sales, and possession of loaded and concealed firearms in public and other miscellaneous mischief in the form of property destruction.

I was able to verify that Zorich claimed his current mailing address on record with the DMV as 14862 Adams Street, Midway City, CA 92655. I conducted a records search through Orange County Superior Court Vision. Zorich is currently out of custody on bail for two separate cases. The cases are:

Based on my training and experience, it is my opinion that there is reasonable cause to believe that the grounds for the issuance of a Search Warrant exist as set forth in Section 1524 of the California Penal Code, based on the afore-mentioned facts and circumstances. Based upon the information contained within this affidavit, as well as my training and experience, I believe a search of 14862 Adams Street, Midway City, CA and 14581 Riata Street, Midway City, CA will reveal evidence in support of weapon possession and gang indicia.

Further, it is my opinion that criminal street gangs revere guns, weapons and ammunition. Criminal street gang members benefit from the mere possession of weapons by elevating the status of the individual who possesses a weapon and of the criminal street gang as a whole. The individual gang member and the criminal street gang as a whole gain power and status within the gang community.

All such weapon possession is evidence of CPC 186.22 (a) & (b)- Active criminal street gang participation and the motivation for criminal activity. These items are evidence, which help prove that the criminal street gang "Varrio Midway City" within the definitions of CPC 186.22 (a) & (b).

Your Affiant believes that these items will tend to connect the premises, locations, persons, and vehicles to be searched with the items to be seized and the case being investigated. Your Affiant requests any written or computer communication in printed or stored medium such as E-mail and chat logs discussing gang indicia and involvement whether in active files, deleted files or unallocated space on the hard drive, floppy drive or any date storage media

It is your Affiant's experience that computer system searches and examinations cannot be completed within ten days in which the Search Warrant must be served and the Return to Search Warrant filed. This is due in part because the Orange County Sheriff's Department Investigators who complete the computer search and examinations commonly have multiple cases working at the same time and it can take several weeks to complete. It is requested that the Search Warrant and Return to Search Warrant be filed and that the computer search, examinations, and investigations be allowed to continue.

Based upon your Affiant's training, experience and conversations that your Affiant had with other Law Enforcement Officers and/or reports that your Affiant has read, your Affiant knows that the involvement in gangs includes the association of numerous individuals. As a result, persons who are involved in gangs will often possess documents that will identify other members of the organization such as telephone book(s), address book(s), telephone

bill(s), and other paperwork documenting the name(s), address(es), and telephone numbers of co-conspirators. It is also your Affiant's experience that co-conspirators will retain address(es) and telephone numbers of other co-conspirators in the same way that a business will maintain records

In the described residence to be searched, I believe there will be, and I wish to seize, indicia of criminal street gang membership; indicia including, but not limited to, photos, graffiti and/or rosters listing not only the gang members outlined in this document, but also additional "Varrio Midway City" gang members

These items include, but are not limited to, any drawing or miscellaneous writing or objects or graffiti depicting gang member's names, initials, logos, monikers, slogans, or containing mention of criminal street gang membership, affiliation, activity or identity. It has been my experience that most criminal street gang members are known by monikers to their fellow gang members and they frequently write their monikers, and the monikers of their associates on walls, furniture, miscellaneous items or paper, both within and on the residence and within and on the vehicles.

It is my opinion that evidence of gang membership or affiliation with a criminal street gang is important as it will provide motive for the commission of the crime in the instant cases and may provide evidence, which will tend to identify other persons who may have knowledge of or be involved in the commission of the crimes in the instant cases, and it may tend to corroborate information given by other witnesses. I believe these items will tend to connect the premises, persons and locations to be searched with the items to be seized and the cases being investigated. I believe these items are not typically disposed of and will therefore likely be found at the location to be searched.

I request that a Search Warrant be issued based upon the aforementioned facts, for the seizure of said property, or any part thereof, between the hours of 7.00 A.M. and 10.00 P.M., good cause being shown thereof, and the same be brought before this Magistrate or retained subject to the order of the court, or of any court in which the offense(s) in respect to which the property of things taken, triable, pursuant to Section 1536 of the Penal Code,
